- Acknowledge and agree that I voluntarily assume the risk of any injury or death to myself and others and I, heirs and assigns forever release, discharge, hold harmless and indemnify the Pacific Sports Management and its related entities, employees, directors, sponsors and officers from any liability including negligence, causes of action, claims, demands, actions, suits or proceedings of any natures (including, without limitation, those for legal costs or outlays), past, present and future, as a result of participating in the Academy.
- PSM shall not be liable to cover or pay to or on behalf of the Insured in respect of any liability, costs and expenses, costs, Claim, Defence Costs, Fine or Penalty, or Privacy Breach directly or indirectly arising out of, related to, or in connection with:
 - a Communicable Disease or the fear or threat (whether actual or perceived) of a Communicable Disease regardless of any other cause or event contributing concurrently or in any other sequence thereto; or
 - any action taken to control, prevent, isolate, quarantine, suppress, mitigate or in any way relating to any actual or suspected outbreak of any Communicable Disease or the fear or threat (whether actual or perceived) of a Communicable Disease;
 - instructions, orders, requests, restrictions or limitations given by any national or local government, regulatory or statutory body, health authority or organisation relating to any Communicable Disease.
- If PSM allege that by reason of this exclusion a Claim, loss or Defence Cost is not covered by this policy, the burden of proving the contrary shall rest with the Insured.
- As used herein, a Communicable Disease means any disease which can be transmitted by means of any substance, medium or agent from any organism to another organism where:
 - the substance, medium or agent includes, but is not limited to, a virus, bacterium, parasite or other organism or any variation thereof, whether deemed living or not, and
 - the method of transmission, whether direct or indirect, includes but is not limited to, airborne transmission, bodily fluid transmission, transmission from or to any surface or object, solid, liquid or gas or between organisms, and;
 - the disease, substance or agent can cause or threaten damage to human health or human welfare or can cause or threaten damage to, deterioration of, loss of value of, marketability of or loss of use of property.

COVID SAFE REGISTRATION

Pacific Sports Management has been registered as a COVID Safe Business as of 27/7/2020 and is operating in compliance with both Queensland and New South Wales Industry Covid safety regulations.

PURPOSE

The Centres for Disease Control and Prevention has issued guidelines for “community mitigation strategies” to limit the spread of COVID-19, which include recommendations for “physical distancing” and “personal hygiene”. This policy provides formal guidance to all Pacific Sports Management (PSM) staff, participants and spectators on the strategies that will be implemented to undertake a conscious effort to assist in the reduction of the spread of the virus.

This strategy has been developed to identify the key risks and associated controls required to reduce the risk of exposure to COVID-19 in the camps environment. PSM are constantly reviewing the advice provided by all levels of Government and relevant health bodies and will continue to review our strategy and update our safety plans and procedures as required.

PERSONAL HYGIENE

The advice provided by the World Health Organisation indicates that strong personal hygiene is one of our best strategies in the prevention of the spread of the illness.

The steps PSM will be undertaking include:

- Appointing a COVID-19 Officer with the responsibility to clean any equipment used pre and post sessions, ensure cleaning products are well stocked and identify risks with physical distancing and hygiene. The COVID-19 Officer will be provided with checklists and guidelines provided by SafeWork Australia to ensure cleaning is up to standard.
- All staff represented at all sessions in the immediate future and longer term time frames will have completed the online government COVID-19 education course.
- Hand sanitiser to be provided - All staff and participants to thoroughly sanitise hands pre and post sessions.
- Participants to provide own drink bottles and water.
- All staff and participants are to refer to the COVID-19 fact sheet and key information required for healthy personal hygiene.
- No access to change rooms at the venue - toilet amenities will be available.
- Any staff, player and spectator with cold/flu like symptoms or high temperatures must not attend and will be denied entry and participation.
- All participants and spectators agree to have their temperature taken on sign-in.
- All participants and parents/guardian's must provide details and answer mandatory declaration questions regarding travel / visitation to Government declared hot spots.

Staff, participants and spectators are expected to:

- Abide by the controls as outlined in this strategy.
- Regularly and thoroughly clean their hands with an alcohol-based hand rub or wash them with soap and water.
- Avoid touching their eyes, nose and mouth. Hands touch many surfaces and can pick up viruses.
- Cover their mouth and nose with their bent elbow when they cough or sneeze.

PHYSICAL DISTANCING

“Physical distancing” should be exercised where practical, which includes remaining 1.5m away from each other in between drills, avoiding all contact (handshakes etc.) and there is a minimum of 4 square metres of space per person within the designated area.

Physical distancing measures that PSM will be implementing include:

- Sessions are conducted in small groups in accordance to the Government requirements of 4m² / person.
- Staff and participants are to adhere to the 1.5m distance rule in between drills and are to ensure they are not working in close proximity with other staff and participants.
- Parents to sign in and sign out participants on arrival. Key addition to signing in and out will be completing a section of the registration attendance requesting information regarding any individual contact with another person that is from any Government declared hot spots within the last 14 days or if they as an individual have travelled to Government declared hot spots within the last 14 days, returned from overseas travel or test positive to COVID-19.

STAFF AND PARTICIPANT HEALTH MANAGEMENT

Reasonable suspicion that a staff member, participant or spectator has the virus

If PSM reasonably suspects that a staff member, participant or spectator could have the virus, has been exposed to other staff or participants, has been recently advised that they have the virus we will:

- Request the staff member or participant to isolate from the environment and the broader community
- Call the QLD / NSW helpline for further advice and guidance;
- If required, ask the staff member or participant to seek medical advice immediately from a doctor or hospital or call the National Coronavirus Helpline on 1800 020 080;
- Clean and disinfect the areas that the staff member, participant or spectator has been in close contact with using PPE, in accordance with SafeWork guidelines;
- If instructed by the public health officials, identify, and inform any other staff member or participant/parents or members of the public that the person has been in close contact with; and
- Review Risk Management controls to identify if any measures require amendments.

WHEN STAFF MEMBERS OR PARTICIPANTS ARE FEELING UNWELL

When a staff member or participant:

- Is feeling unwell and develops symptoms such as a fever, cough, sore throat or shortness of breath; and/or;
- Has travelled internationally, to any country; and/or
- Has been in contact with someone who has or may have been in contact with someone who has had a positive test for COVID-19;

They must not present at any PSM session. The staff member and/or participant should seek medical advice immediately from a doctor or hospital or call the National Coronavirus Helpline on 1800 020 080.

Staff members and/or participant are not to present at PSM sessions until they can provide evidence that they are fit to attend.

SELF-ISOLATION

Based on the most recent advice from the World Health Organisation and the Australian Government, we will require staff members and/or participants to self-isolate for 14 days if:

- Staff members and/or participants have returned from travelling internationally, to any country; and/or
- If they have been in contact with or may have been in contact with, someone who has a positive test for COVID-19.

In these situations, we will:

- Consult with the staff member and/or participant/parents about the isolation period and the best way to support them.

VULNERABLE STAFF MEMBERS OR PARTICIPANTS

If a staff member or participant is vulnerable to COVID-19 due to an underlying health condition or their age, they will be encouraged to speak with the COVID-19 officer directly to determine an individual strategy.

UPDATES AND REVIEW

PSM Directors will be discussing the controls of COVID-19 with the appointed Covid Officer. This situation is rapidly changing, and we will continue to monitor the situation and act in accordance with the Australian Government, public health orders and SafeWork Australia guidelines. PSM may be required to provide staff and participants with any updates as they arise.
